The art competition at the elementary schools will again be supported. It was suggested to perhaps lower the competition to just elementary grades. June 10th at 5:30 P.M. will be the reception at the Library for the most recent art prize winners.

Jim and Lisa will work together on plans to support the Sales Tax Levy.

Old Business was carried over to our next meeting in September.
